The motion carried. The executive session began at 7:37 p.m. and ended at 8:06 p.m. The chair announced that no decisions were made and no actions were taken.

Cm. Marstiller, seconded by Cm. Woolwine, MOVED ADOPTION OF RESOLUTION 868, AGREEMENT WITH ELKINS PARKS AND RECREATION COMMISSION CONCERNING MANAGEMENT OF OLD ELKINS NATIONAL GUARD ARMORY. Marstiller stipulated two amendments to the resolution as presented in packets: (1) personnel costs for the armory manager would be split equally between the city and the EPRC, and (2) the city and the EPRC would have the right to terminate the agreement with 90 days' notice. <u>The</u> <u>motion carried.</u>
