Elkins Common Council Regular Council Meeting Minutes

Elkins Common Council met in regular session in the council chamber of city hall. Present were Mayor Van T. Broughton; Councilpersons R.C. Chenoweth, M. D. Cuonzo, C. Friddle, III, M.M. Hazen, C.C. Lowther (arrived at 7:55 pm), C. L. Metheny, E.R. Ochsendorf, D.C. Parker, L.H. Vest and R. A. Woolwine; Police Chief J.C. Raffety; Fire Chief T. W. Meader; Operations Assistant M. Himes; City Attorney G. S. Roberts; City Clerk J.R. Sutton (acting as recording secretary); and Inter-Mountain Reporter B. Henry-Vance.

City Treasurer T. Judy and Operations Manager R.P. Pingley were absent.

PUBLIC COMMENT

Rhett Dusenbury of 140 Easy St, Elkins provided council with a copy of the Town Voice, a publication distributed by the Mooresville, NC governing body to its citizens. Mr. Dusenbury highlighted an article within regarding the municipality's budget process.

PRESENTATION

Beth King from the Augusta Heritage Center presented information about the upcoming Augusta Heritage Festival and additional programs throughout the year. The Festival series of classes, dances and concerts begins on July 9th and ends with the festival in City Park on August 12th. They hope to have approximately one-thousand participants this summer. The Center has a large scholarship program and have awarded one-hundred eleven partial or full scholarships to participants this year. The Center contributes to the community through cultural and artistic events and preservation as well as economically when participants lodge, eat and tour for the six days they are enrolled.

With council's permission, item f was moved to the top of the agenda. Ptl. Tice, of the Elkins Police Department, presented information to council regarding the Veteran's program which

would facilitate the acquisition of a single purpose narcotics dog and accompanying training to him.

Cm. Metheny MOVED APPROVAL OF RESOLUTION 1038: APPROVAL OF THE ELKINS POLICE DEPARTMENT ACQUISITION OF A NEW K-9 MEMBER. <u>The motion carried</u>.

Dave Cutlip, co-chair of the Elkins Main Street Design Committee, presented council the parking plans recommendations created collaboratively between city officials and Main Street representatives. The plan was brought to council for discussion by the Municipal Properties Committee. One of the concerns addressed was the downtown flag display by the American Legion on certain federal holidays. Cm. Metheny recalls that in the past the flags were horizontally mounted in the sidewalk and that this was attractive. Cm. Friddle expressed concern over the loss of revenue if all the meters are removed and would like more information prior to making a decision. Cw. Hazen recommended reverse angle parking as opposed to parallel parking to increase the number of available spaces downtown.

Cm. Metheny MOVED THE PARKING PLAN RECOMMENDATIONS BE REFERRED BACK TO THE MUNICIPAL PROPERTIES COMMITTEE FOR FURTHER REVIEW. <u>The motion carried.</u>

Cm. Metheny **MOVED COUNCIL ENTER INTO EXECUTIVE SESSION FOR THE PURPOSE OF DISCUSSING AGENDA ITEMS B AND D UNDER ATTORNEY CLIENT PRIVILEGE.** <u>The motion carried.</u> Council entered executive session at 7:45 p.m. and returned at 8:35 p.m. The chair announced that no action was taken.

Cm. Friddle III MOVED APPROVAL FOR THE CITY TO RETAIN THE SERVICES OF BRYSON VAN NOSTRAND TO ASSESS THE PRESENT CONDITION AND RECOMMENDED NECESSARY UPGRADES FOR THE FUTURE USE OF CITY HALL. <u>The motion carried.</u>

Cm. Friddle III MOVED APPROVAL FOR THE CITY TO RETAIN THE SERVICES OF BRYSON VAN NOSTRAND TO ASSESS THE PRESENT CONDITION AND RECOMMENDED NECESSARY UPGRADES FOR THE FUTURE USE OF THE PHIL GAINER COMMUNITY CENTER. <u>The motion</u> <u>carried.</u>

Cm. Friddle III MOVED APPROVAL OF THE EXPENDITURE OF CITY FUNDS UP TO \$25,000 AS MATCHING FUNDS FOR THE RURAL CAPACITY DEVELOPMENT INITIATIVE GRANT. <u>The motion carried.</u>

Cm. Woolwine MOVED APPROVAL FOR ROBERT RODECKER OF KAY CASTO AND CHANEY LAW PLLC TO REVIEW AND RECOMMEND THE CITY OF ELKINS RESPONSE TO THE TYGARTS VALLEY TRANSFER REQUEST FOR RATE INCREASE TO THE WV PUBLIC SERVICE COMMISSION. <u>The motion carried.</u>

City Clerk J. Sutton provided a brief history of the Elkins Building Commission to council including the lack of any current members. City Attorney G. Roberts explained the purpose of the commission and that as of right now, there is no pending business.

Cm. Metheny MOVED APPROVAL FOR THE CITY TO ISSUE A LETTER OF SUPPORT FOR THE MOUNTAIN STATE FOREST FESTIVAL'S REQUEST TO THE WV ABCA FOR A CLASS A LICENSE. The motion carried. Cm. Woolwine abstained from the vote due to his service on the MSFF Board.

Cw. Cuonzo MOVED APPROVAL OF RESOLUTION 1039: APPOINTING A POLICE CHIEF AND ESTABLISHING THE AMOUNT OF ANNUAL COMPENSATION. <u>The motion carried</u>.
