# ELKINS COMMON COUNCIL REGULAR MEETING MINUTES

#### **PUBLIC COMMENT**

Mark Doak, owner of multiple buildings in downtown Elkins, spoke on behalf of some downtown business owners and presented a handout to Elkins City Councilmembers. He would like for the 1% Sales Tax Proposal to be tabled.

Martha Metheny, 1700 Taylor Avenue, Elkins, owner of multiple buildings and a business in downtown Elkins, along with her husband, wishes for the 1% Sales Tax Proposal to be tabled.

Rhett Dusenbury of Rep. Alex Mooney's Office commented that our public comment was a good example of an exercise of our constitutional rights and wished everyone a Happy Thanksgiving.

Kevin Howell, manager of a business at 501 Randolph Avenue, Elkins, spoke on how this 1% Sales Tax Proposal has brought the members of the Elkins business community together against the proposal.

Carman Metheny, Third Ward Councilman and Hanley Street, Elkins resident, spoke on behalf of the Finance Committee regarding the budget process for the City of Elkins. Mr. Metheny explained that each year the council cuts departmental budgets by ten percent, and that everything they do is totally transparent. The members of the community are welcome to the meetings and Mr. Metheny feels like each community member should serve a term on Council to see if they could do a better job.
