Bryson VanNostrand, of VanNostrand Architects PLLC, presented a report to Council detailing his assessments of City Hall and the Phil Gainer Community Center, including existing conditions and recommended actions. Both of these buildings are considered historic and some level of consideration must be given when undergoing renovations.

Chris Lee, Phil Gainer Community Center Facilities Manager, reported the past and upcoming events scheduled at the Center. Mr. Lee also thanked Council for approving the purchase of the scissor lift and the PA system, as they have gotten a lot of use out of both of these. Mr. Lee is asking Council for support in installing air-conditioning into the facility and for the implementation of an after-school program to serve middle-school aged children. The EREC is also considering creating an AmeriCorps position to help staff the PGCC.
