Elkins Welcome Depot Center Executive Director Anne Beardslee reported to council that so far this year the number of visitors to the Depot had increased by 250 people. The recent Ramps & Rail Festival was a huge success and Mrs. Beardslee thanked the City for their participation and support. The Depot is excited to receive an increase in funding and to have created a new arm dedicated to marketing and tourism, the Elkins-Randolph County Tourism CVB. Mrs. Beardslee introduced Taira Landevere the newly hired Director of Marketing for the organization. Mrs. Landavere addressed council, remarking that she is excited to move forward. She will be working with a marketing committee to develop a marketing plan. She is also partnering with the Beverly Heritage Center and has launched both a Facebook and Instagram account for the CVB.
