INSTRUCTIONS

- Determine your Business Classification.
- Taxes are based on Gross Receipts. Please enter your gross receipts in the appropriate box on the front of form.
- Gross amount **should not** include Federal or State excise tax and sales taxes imposed on the customer.
- Multiply the gross amount by the rate multiplier indicated and enter tax due.
- All tax returns are due **one month after the end of applicable filing period** (i.e. April 30, July 31, October 31, January 31)
- Penalties will be applied against any return that is postmarked after these due dates. Penalties are 5% for the first month or fraction thereof of delinquency, and 1% for each succeeding month or fraction thereof of delinquency. You may also calculate and pay these on your return before mailing a late return.
- If no reportable activity occurred during the filing period and not tax is due, please indicate this on the return and submit by the due date. This will avoid unnecessary delinquent notices. **Even if no tax is due, this tax return must be completed.**
- Sign and date the return. This return is invalid unless it is signed.
- If part of your gross income is taxed by another city, you are required to submit a copy of the return you filed with the other city.
