REGULAR COUNCIL MEETING July 21, 2011

Elkins Common Council met in regular session in the council chamber of city hall at 7:05 p.m. Thursday, July 21, 2011. Present were Mayor Duke Talbott; Councilpersons: J. S. Bibey, N. E. Cw Cuonzo, seconded by Cm Hensil, MOVED COUNCIL ACCEPT MINUTES PROPOSED FOR THE REGULAR MEETING OF JULY 7, 2011 AS PRESENTED. The motion carried.

UNFINISHED BUSINESS

Cw Cuonzo, seconded by Cw Bross-Fregonara, MOVED THAT COUNCIL APPROVE OF AND ADOPT THE PROPOSAL FOR A SUBSTANCE ABUSE POLICY. The motion carried.

Cw Cuonzo, seconded by Cm Hensil, MOVED THAT COUNCIL ACCEPT THE PROPOSAL OF THE PERSONNEL COMMITTEE AS TO EDUCATION ABOUT AND IMPLEMENTATION OF THE ADOPTED SUBSTANCE ABUSE POLICY. The motion carried.

NEW BUSINESS

Cw Bross-Fregonara, seconded by Cm Satterfield, MOVED COUNCIL APPOINT GRACE W. SUNDELIN TO THE BOARD OF ZONING APPEALS, TO FILL THE UNEXPIRED TERM CREATED BY THE RESIGNATION OF GRANT NESTOR. The motion carried. [The term will expire December 31, 2013.]

Cw Cuonzo, seconded by Cm Hensil, MOVED COUNCIL ADOPT RESOLUTION 270, APPROVING INVOICES RELATING TO THE PROPOSED WATER SYSTEM IMPROVEMENTS PROJECT AND AUTHORIZING PAYMENT DRAWDOWN #40 THEREOF FROM FUNDS AVAILABLE FROM THE WATERWORKS SYSTEM DESIGN BOND ANTICIPATION NOTES, SERIES 2007. The motion carried.

Cm Satterfield, seconded by Cm Scott, MOVED COUNCIL APPOINT SANDRA H. GRAHAME TO THE BOARD OF THE ELKINS-RANDOLPH COUNTY PUBLIC LIBRARY FOR A 5-YEAR TERM COMMENCING JULY 1, 2011. The motion carried.

Cm Woolwine, seconded by Cw Cuonzo, MOVED THAT COUNCIL GRANT THE REQUEST TO PERFORM THE BILL PROUDFOOT MEMORIAL WALK/RUN. The motion carried.

Cm Woolwine, seconded by Cw Cuonzo, MOVED COUNCIL APPROVE OF AND AUTHORIZE A PROFESSIONAL SERVICES CONTRACT WITH THE ACCOUNTING FIRM OF TETRICK AND BARTLETT, PLLC TO AUDIT THE

FISCAL YEAR 2011 RESULTS OF THE WATER AND SEWER ENTERPRISE FUNDS AND TO FILE THE ANNUAL WV PUBLIC SERVICE COMMISSION UTILITY REPORTS. The motion carried.

The authority of the board of park and recreation commissioners was discussed. Making reference to West Virginia Code §8-21-7. *Office; powers,* the city attorney expressed her opinion that the board was an autonomous body, with "...complete and exclusive control and management of all properties which shall be operated in connection with the public park and recreation system...and shall have power to employ such persons as...may be necessary for the establishment, construction, improvement, extension, development, maintenance or operation of the property under its control, at such wages or salaries as it shall deem proper, and shall have full control of all employees."

Cm Hensil, seconded by Cm Woolwine, MOVED COUNCIL APPROVE VENDOR INVOICES AS THEY APPEARED ON THE DATA SHEET PRESENTED. The motion carried.

The potential for regulation of Marcellus Shale drilling within the city limit was mentioned.

Cm Woolwine, seconded by Cm Hensil, **MOVED COUNCIL ENTER EXECUTIVE SESSION FOR CONSIDERATION OF A PERSONNEL MATTER.** The motion carried. Council entered executive session at 8:05 p.m.; regular session resumed at 8:55 p.m. No decisions were made; no actions were taken.

COMMITTEE REPORTS

BUILDING

The committee received 23 applications since the last meeting of council. Nineteen applications were residential and four were commercial. Application 715 was void. Acting upon recommendation of the building inspector, the committee approved all applications.
